#### HKC's application and conditions for entry into force -

- Applicable ships: International ships of 500 GT or more
- Conditions necessary for entry into force
  - 1. No. of contracting parties: <u>15 states</u>
  - 2. Fleet: <u>40% of GT of the world's merchant shipping</u>
  - Recycling capacity: Maximum annual ship recycling volume of the signing states during the preceding 10 years constitutes not less than <u>3% of GT of the states</u>.
- The HKC will enter into force 24 month after when the above conditions are met.
- Three states have acceded (ratified): Norway, Congo, and France (as of 1<sup>st</sup> Nov., 2014)



Six states have acceded(ratified): Belgium, Congo, Denmark, France, Norway, and Panama (as of 13 July 2017) 6 states with 20% of GT of the world's merchant shipping

We need 9 states with more than 20% of GT of the world merchant shipping, including major shipbreaking country such as India and China!
