Rio Tinto Global Union Network calls for limit on precarious work, improved conditions for precarious workers

Dear Mr Jacques,

We, leaders of unions of the Rio Tinto Global Union Network, representing thousands of Rio Tinto workers in 13 countries, are urging Rio Tinto to collaborate with us globally to limit the use of precarious work and improve the working conditions of precarious workers at Rio Tinto.

We have found in our respective countries that Rio Tinto is increasingly using precarious work, including temporary, casual and contracted-out workers who have worse conditions than regular, direct employees. This harms Rio Tinto workers and their communities, causes conflict, and can undermine Rio Tinto's social license to operate.

We raised this concern exactly one year ago on 7 October, the World Day of Decent Work, in a letter to your predecessor Sam Walsh, however he did not reply. The problem of precarious work at Rio Tinto has become worse since then. We hope that you are more open to working with us on this issue.

On behalf of the thousands of our members that work for Rio Tinto, we seek the following:

A limit on precarious work:

- Stop replacing permanent workers by precarious workers
- Limit the use of precarious work to legitimate needs (like addressing short term labour shortages due for example to production fluctuations)
- Favor direct employment over indirect employment
- Promote and encourage training throughout employees' careers
- Set a global limit in Rio Tinto Group for precarious work
- Prior consultation of unions on use of precarious work

Improved working conditions for precarious workers

- Equal treatment for equal work
- Better control of suppliers and sub-contracting companies in their compliance with global labour standards
- Participation of the union in monitoring this compliance and in precarious workers' working conditions
- Improvement of health and safety risk management system for precarious workers

We hope to work collaboratively with Rio Tinto to find global solutions to address this global problem.
